ORDER APPROVING TARIFF

On April 5, 2023, Missouri-American Water Company (Missouri-American) filed the above-referenced application. The Commission approved the application on June 7, 2023. In the order approving the application, the Commission ordered Missouri-American to file a tariff.

Missouri-American filed Tariff Tracking Nos. YW-2023-0218 and YS-2023-0219 on June 14, 2023. The tariffs bear an effective date of July 14, 2023.

The Commission's Staff filed a Recommendation on June 20, 2023. The Recommendation stated that the Commission should approve the tariffs. No other responses were received.

The Commission finds that the tariffs comply with the Commission's June 7, 2023 order. The Commission will approve the tariffs.

THE COMMISSION ORDERS THAT:

1. The tariffs filed by Missouri-American on June 14, 2023, and assigned Tracking No. YW-2023-0218 and YS-2023-0219, are approved to become effective on July 14, 2023.

2. This order shall be effective July 14, 2023.
