ORDER APPROVING TARIFF IN COMPLIANCE WITH COMMISSION ORDER

On March 17, 2023,¹ Liberty Utilities (Midstates Natural Gas) Corp. d/b/a Liberty filed an application to change its Infrastructure System Replacement Surcharge (ISRS). On July 12, the Commission issued its *Order Rejecting Tariff and Authorizing ISRS Rates* (Order) rejecting the previously filed tariff sheet, Tracking No. YG-2023-0173, and authorizing the Company to submit a tariff sheet in compliance with the Order.

On July 13, Liberty filed a tariff sheet purported to be in compliance with the Order. The submitted tariff sheet has a 30-day effective date of August 12, and is assigned Tracking No. YG-2024-0004.

Thereafter, Staff filed its expedited recommendation, which advised the Commission to approve the compliance tariff. Staff stated it had no objections to the request for expedited treatment. No other party responded to Liberty's compliance tariff. No party responded to Staff's recommendation.

Upon reviewing the pleadings, the Commission finds that Liberty's tariff sheet complies with the Commission's Order and will approve it. To allow this tariff to go into
