On June 26, 2020, Osage Utility Operating Company, Inc. ("Osage Utility"), filed compliance tariff sheets, including an Adoption Notice, with the Commission. The tariff sheets were assigned YW-2020-0218 and YS-2020-0219, approved by the Commission and became effective July 29, 2020. Ordered Paragraph 5 in the Commission's *Report and Order* in this case states that the Commission's grant of authority does not include Osage Beach South, Osage Beach North, Sunrise Beach South, Sunrise Beach North, Shawnee Bend, and Parkview Bay, areas in which Osage Water Company was no longer providing service. The purpose of this filing is to file revised tariff sheets to remove these water service areas from Osage Utility's currently effective water service tariff. The above-mentioned service areas are not contained in the currently effective sewer service tariff.

Further, after discussions with Staff, the revised tariff sheets also seek to remove duplicative water service charges that are now contained in Sheet No. 6A. The water service charges in Tariff Sheet No. 6A were modified in WR-2009-0149, by Tariff Sheet No. 6 (assigned Tariff Tracking No. YW-2010-0097). Tariff Sheet No. 6A remained in the effective tariff in error.
