ORDER CANCELING CERTIFICATES AND ACCOMPANYING TARIFFS

Issue Date: May 7, 2015

Effective Date: May 17, 2015

On April 17, 2015, the Staff of the Missouri Public Service Commission filed a motion requesting Trans National Communications International, Inc. ("Trans National") certificates of service authority and accompanying tariffs to provide competitive basic local and interexchange telecommunication services in the State of Missouri be cancelled.

In File Numbers TA-2000-237 and CA-2005-0133, the Commission granted Trans National certificates of service authority to provide competitive basic local and interexchange telecommunication service in the State of Missouri. The Company's tariffs, P.S.C. Mo No. 2, 3, and 4, were also approved.

Staff states in its motion that Trans National contacted Staff via electronic mail stating Trans National planned to request the Commission cancel Trans National's certificates of service authority. Staff noted that Trans National never made a filing requesting the cancellation and did not make requisite filings of the Company's annual reports. Staff recommends that the Commission cancel the company's certificates of service authority to provide competitive basic local and

interexchange telecommunications services, and the company's accompanying tariffs.

On April 20, 2015, the Commission issued an Order Establishing Time to Respond allowing any parties to file an objection or request a hearing to do so no later than April 30, 2015. No objections or requests for a hearing were filed.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate or service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Staff's motion, the Commission finds that the certificates of service authority and accompanying tariffs granted to Trans National Communications International, Inc., shall be canceled.

IT IS ORDERED THAT:


1. The certificate of authority to provide competitive basic local and interexchange telecommunications services granted to Trans National Communications International, Inc., in File Numbers TA-2000-0237 and CA-2005-0133, are canceled.

2. Trans National Communications International, Inc.'s tariff, P.S.C. Mo Nos. 2, 3, and 4, are canceled.

3. This order shall become effective on May 17, 2015.

4. This case may be closed on May 18, 2015.
