ORDER APPROVING DEMAND SIDE INVESTMENT MECHANISM RIDER RATE ADJUSTMENT

Issue Date: July 20, 2017 Effective Date: August 1, 2017

On June 1, 2017, Kansas City Power & Light Company ("KCPL") filed an application under the Missouri Energy Efficiency Investment Act ("MEEIA") to adjust its Demand Side Investment Mechanism ("DSIM") rider and submitted a tariff sheet with an effective date of August 1, 2017, to implement the proposed adjustments. The tariff sheet was subsequently substituted on June 23 and June 28, 2017. The Missouri Department of Economic Development – Division of Energy was the only party that filed a notice of its intention to participate in this matter under Commission Rule 4 CSR 240-3.163(9)(A).

Commission rules require KCPL to make semi-annual adjustments of its DSIM rates to reflect the amount of revenue that have been over or under-collected. The proposed DSIM rates are designed to collect approximately \$19.9 million over the period of August 1, 2017 through January 31, 2018. KCPL's requested adjustment would result in an increase in the DSIM Rider rate of a typical residential customer using 1,000 kWh by

\$1.52 per month and an increase in the DSIM Rider rate for non-residential customers of \$0.69 for every 1,000 kWh used.

The Commission's Staff filed a recommendation regarding KCPL's DSIM rider tariff on June 30, 2016, advising the Commission to approve the tariff sheet submitted by KCPL. Staff explains that this DSIM filing: (1) continues to include the earned performance incentive award that is the result of evaluation, measurement, and verification for KCPL's MEEIA program performance in Cycle 1, (2) includes a correction regarding certain energy efficiency measure installation reporting in past DSIM rate calculations, (3) includes a correction regarding the reporting used to normalize billing determinants in KCPL's rate case ER-2016-0285, (4) corrects errors in calculating the DSIM rate calculation that was implemented in ER-2017-0167 and Tariff Tracking No. JE-2017-0111 which took effect February 1, 2017 and remains in effect at this time, and (5) includes a "rebasing adjustment" as permitted on Tariff Sheet 49K which reduces the amount collected for throughput disincentive. No other party filed a response or objection to the Staff recommendation.

The Commission's rule regarding adjustment of DSIM rates between general rate proceedings states that if the proposed adjustments are in accordance with the rule, Section 393.1075, RSMo, and the previously-approved DSIM, the Commission shall issue an order approving the tariff sheets, and the adjustments shall take effect sixty days after the tariff sheets were filed.² The Commission has reviewed KCPL's tariff filings and Staff's verified recommendation and memorandum, and finds that the proposed tariff sheet implementing the DSIM rate adjustment is in compliance with KCPL's existing DSIM tariffs

and with all applicable statutes and regulations. Therefore, the Commission will approve KCPL's proposed tariff.

THE COMMISSION ORDERS THAT:

1. Kansas City Power & Light Company's tariff filing, assigned Tariff Tracking No. JE-2017-0252, as substituted, is approved to be effective August 1, 2017, as an interim rate adjustment, subject to prudence review. The tariff sheet approved is:
