**APPLICATION FOR THE APPROVAL OF AGREEMENT**

COMES NOW Missouri-American Water Company ("MAWC") and, in support of its Application for approval of an agreement with MLM Properties, Inc (hereinafter "MLM") of a Water and/or Sanitary Sewer Service Agreement states:

1. MAWC is a Missouri corporation duly organized and existing under the laws of the State of Missouri with its principal office and place of business located at 727 Craig Road, St. Louis, MO 63141. A Certificate of Good Standing from the Office of the Missouri Secretary of State was filed in Commission Case No. SA-2007-0316 and is hereby incorporated by reference in accordance with Commission Rule 4 CSR 240-2.060(1)(g).
2. MAWC currently provides water service to the public in and around the cities of St. Joseph, Joplin, Brunswick, Mexico, Warrensburg, Parkville, Riverside, Jefferson City, and parts of St. Charles and Platte Counties Missouri, and most all of St. Louis County, Missouri. MAWC currently provided water service to approximately 459,000 customers. MAWC provides sewer service to approximately 1,000 customers near Parkville, Cedar Hill and Warren County, Missouri. MAWC is a "water corporation" and a "public utility" as those terms are defined in Section 386.020 and 393.1000(7) RSMo. 2000, and is subject to the jurisdiction and supervision of the Commission as provided by law.


4. According to Rule 10 of the Warren County Sewer Tariffs the attached agreement (Appendix A) is subject to approval by the Missouri Public Service Commission.


