On September 30, FairPoint Communications Missouri, Inc. d/b/a FairPoint Communications filed a tariff revision request to increase the business and residential local exchange access line rates by \$2.00. This change will also increase the overall bundle rates for Home Phone, Full House, Voice Advantage, and Small Business bundles by \$2.00 as all of these packages have local tariff components and toll components. The sum of the local and toll components combine to equal the total package price. Both the EPAK II and Voice Advantage II packages are exempt from this increase. Toll allocations were adjusted accordingly with in these bundles to maintain the same total package price.

Attached for the Commission's information is a copy of the customer notification verbiage that will accompany this rate increase. This notice will be provided to customers beginning with the October 16 bill cycle. The change is scheduled to be effective December 1, 2014.
