On June 1, 2012, the Commission received the application with tariff sheets. On June 21, 2012, the Commission's staff filed its recommendation in favor of granting the application, and approving tariff sheets or allowing them to take effect by operation of law. Because no party disputes the application, no law requires a hearing before granting the application, so the Commission convened no hearing and bases its findings on the verified filings.<sup>1</sup>

Therefore, the Commission will grant the application and recognize the name change. The Commission will also approve the tariff sheets. The tariffs' proposed effective
