ORDER APPROVING TARIFF

Issue Date: April 19, 2017

Effective Date: May 5, 2017

On April 5, 2017, Missouri-American Water Company filed a consolidated sewer tariff that creates a single tariff to replace its current multiple sewer tariffs. The consolidated tariff carries a May 5 effective date.

Missouri-American explains that it committed to filing a consolidated sewer tariff in a stipulation and agreement that was approved in its most recent rate case, File No. WR-2015-0301. The details of the tariff were developed by a working group, including Missouri-American, Staff, Public Counsel, and the City of Riverside, that was created as a result of the stipulation and agreement.

The Commission ordered its Staff to file a recommendation regarding the tariff by April 14. It also ordered that any other party wishing to respond to Missouri-American's tariff do so by that date. Staff filed its recommendation on April 13, advising the Commission to approve the consolidated tariff and to cancel Missouri-American's existing sewer tariffs. No one has opposed the tariff.

The Commission will approve the submitted tariff to take effect on its proposed effective date, and will cancel Missouri-American's existing sewer tariffs.

THE COMMISSION ORDERS THAT:

1. The proposed tariff submitted under Tariff No. YS-2017-0192 by Missouri-American Water Company is approved, as substituted, effective on and after May 5, 2017.
