ORDER APPROVING THIRD QUARTERLY COST ADJUSTMENT TARIFF

The Missouri Public Service Commission is approving the pending tariff sheet, which sets forth the quarterly cost adjustment ("QCA") for Evergy Missouri West, Inc. d/b/a Evergy Missouri West (EMW) in calendar year 2022, third quarter. EMW filed the tariff on October 14, 2022, with an effective date of December 1. Staff filed its recommendation on November 9, stating that the tariff meets the requirements of EMW's tariff sheets 6.6 through 6.10. Staff recommends the Commission approve that tariff. Greater than ten days have passed and the Commission received no response to Staff's recommendation. No other comments on EMW's tariff have been received by the Commission.

The Commission concludes that the tariff complies with EMW's tariff sheets 6.6 through 6.10, and will support safe and adequate service at just and reasonable rates. The Commission will approve the tariff.

As the tariff filing is unopposed, and so that this tariff may go into effect expeditiously on the requested effective date, the Commission finds it reasonable to make this order effective in less than 30 days.
