Dear Ms. Dippell:

Accompanying this letter for filing via the Commission's Electronic Filing and Information System (EFIS) are revised tariff sheets per the Commission's June 14, 2023 Report and Order, which are designed to increase Ameren Missouri's gross annual electric revenues by approximately \$140 million, exclusive of applicable gross receipts, sales, franchise or occupational fees or taxes. The tariffs also rebase net energy costs to reflect changes in the net energy costs currently included in base rates, which absent the filing of this rate increase request, would have been included in periodic adjustments under Ameren Missouri's existing fuel adjustment clause (Rider FAC), and renewable energy standard costs and benefits that would have been included in Rider RESRAM adjustments.

When the Company initially filed this electric rate review, the LPS cap under Section 393.1655.6, RSMo., was not triggered. However, the combination of changes in the rates charged under Riders FAC and RESRAM in combination with the agreed upon revenue requirement increase under the approved April 7, 2023 Stipulation and Agreement result in an exceedance of the LPS cap. That exceedance has been allocated to all the electrical corporation's other customer classes through the application of a uniform percentage adjustment to the revenue requirement responsibility of all the other customer classes as required by Section 393.1655.6. ¹

The accompanying tariff sheets are transmitted to you for filing as a revision of Union Electric Company's Schedule No. 6, Schedule of Rates for Electric Service in accordance with the Commission's June 14, 2023 Report and Order:
