ORDER APPROVING COMPLIANCE TARIFFS

Issue Date: September 14, 2017

Effective Date: September 29, 2017

After the Commission issued its July 26, 2017 *Order Approving Disposition Agreements and Small Company Rate Increase*, Terre Du Lac Utilities Corporation ("Terre Du Lac") submitted revised tariff sheets (Tracking Nos. YS-2018-0024 and YW-2018-0025) with a September 29, 2017 effective date. On August 31, 2017, the Commission issued an order directing the Commission's Staff to report if Terre Du Lac's tariff sheets complied with the Commission's July 26, 2017 order. The Commission also set a September 11, 2017 deadline for the filing of objections to Terre Du Lac's revised tariff sheets, but no objections were filed.

On September 6, 2017, Staff submitted a recommendation that the Commission approve Terre Du Lac's revised tariff sheets. After reviewing the tariff sheets, Staff determined they comply with the Commission's July 26, 2017 order. Staff did note that the rate design submitted by the parties as a *Proposed Rate Design* attachment to the Commission-approved *Unanimous Stipulation and Agreement* incorrectly reflected a service charge of \$14.50 for 5/8" and 3/4" meters. Upon discovering the error, the parties corrected the calculations of the service charge in order to set a rate consistent with the

gross annual revenue requirement approved in the Commission's July 26, 2017 order. The corrected service charge rate of \$14.85 for 5/8" and 3/4" meters is reflected in Terre Du Lac's revised tariff sheets.

The Commission will approve the compliance tariff sheets to go into effect on the proposed effective date of September 29, 2017.

THE COMMISSION ORDERS THAT:

1. The tariff sheets submitted by Terre Du Lac Utilities Corporation and identified by Tracking Nos. YS-2018-0024 and YW-2018-0025 are approved to become effective on September 29, 2017.
2. This order shall become effective on September 29, 2017.
3. This file shall close on September 30, 2017.
