These tariff sheets are being issued November 16, 2018 to become effective on and after December 16, 2018.

The primary purpose of the proposed tariff revisions is to extend the Voluntary Green/Pure Power pilot program through December 31, 2020, so that the service being provided to approximately 4,800 customers, currently, will not be terminated December 31, 2018, as anticipated in the existing tariff. Secondly, MPSC Staff had previously requested that the status of the program be revised to remove its pilot status since this program has been in operation for in excess of 10 years. Thus, it is being relocated to the "Riders" section of Ameren Missouri tariffs. Due to limitations in the tariff numbering available in the Riders section, it is appropriate to replace an existing tariff (Rider SP) that expired on December 31, 2014, and has been inactive since that time.

The Voluntary Green/Pure Power program is in its 11th year of operation. Pure Power has proven successful and provides an opportunity for customers to support renewable energy production in an inexpensive way. The program has typically served between 4,000 and 5,000 residential and business customers. Over the past year, Pure Power has increased from 4,000 to 4,800 customers. All costs of the program are paid for by the participants in the program and no costs are charged to nonparticipating customers. Pure Power is a stable offering within the suite of renewable programs developed by Ameren Missouri. It provides customers with an alternative to either installing solar on their roof or subscribing to Community Solar or Renewable Choice.

The proposed tariff revision was provided to Missouri Public Service Commission Staff prior to filing.
