ORDER APPROVING TARIFF

Issue Date: October 29, 2014 Effective Date: November 1, 2014

On October 17, 2014 Summit Natural Gas of Missouri, Inc. ("Summit"), filed a tariff sheet with a November 1, 2014 effective date. The tariff sheets reflect a change in Summit's Purchased Gas Adjustment ("PGA") factor as a result of estimated changes in the cost of natural gas, as well as changes in the Actual Cost Adjustment ("ACA") factor for the 2014-2015 winter season. Summit's filing will increase the firm PGA factor for the winter season for Summit's territory previously known as Southern Missouri Natural gas to \$0.6652 per hundred cubic feet ("Ccf"), from the current firm PGA factor of \$0.5754 per Ccf. This represents an increase of \$0.0898 per Ccf.

The Commission's Staff filed its recommendation on October 23, 2014. Staff recommends the rate be approved on an interim basis, subject to refund pending final Commission decisions in File Nos. GR-2015-0102 and GR-2014-0097. Staff also asks to be allowed until December 18, 2015 to submit its results and recommendations regarding the information included in Summit's ACA filing.

The Commission has reviewed the proposed tariff sheets and Staff's recommendation. The Commission set an October 27, 2014, deadline for entities to submit comments on Summit's tariff or Staff's recommendation, but no comments were received. The Commission finds that the proposed tariff sheet conforms to Summit's Commission-approved PGA Clause. In addition, because Summit's PGA clause allows for PGA change filings to take effect on 10-days' notice, good cause has been shown pursuant to Section 393.140(11), RSMo 2000, to permit the tariff to become effective on less than 30-days' notice. The Commission concludes that the proposed tariff sheet should be approved to become effective on November 1, 2014, on an interim basis, subject to refund, pending final Commission decisions in File Nos. GR-2015-0102 and GR-2014-0097.

THE COMMISSION ORDERS THAT:

1. The proposed tariff sheets filed on October 17, 2014, by Summit Natural Gas of Missouri, Inc., assigned Tracking Number YG-2015-0166 and bearing an effective date of November 1, 2014, is approved on an interim basis, subject to refund, pending final Commission decisions in File Nos. GR-2015-0102 and GR-2014-0097. The tariff sheet approved is:

2. Staff's Procurement Analysis Department shall submit its results and recommendations regarding the information included in Summit's ACA filing on or before December 18, 2015.
