ORDER CANCELING CERTIFICATE AND ACCOMPANYING TARIFF

Issue Date: September 27, 2007 Effective Date: October 7, 2007

On June 7, 2007, the Staff of the Commission filed a motion asking the Commission to cancel the certificate of service authority and tariff of ACCXX Communications, LLC to provide intrastate interexchange telecommunication service in Missouri.

In Case Number TA-2002-461, the Commission granted ACCXX Communications, LLC a certificate of service authority to provide intrastate interexchange telecommunications service. ACCXX's tariff, P.S.C. Mo. Tariff No. 1, was approved in the same case.

Staff's motion states that ACCXX is a Delaware "active" limited liability company according to the Missouri Secretary of State's Office, and as an LLC is not obligated to submit reports to the Missouri Secretary of State. The last communication in the Secretary of State's records is from 2002.

Staff's motion states the telephone number ACCXX provided to the Commission is no longer a working number and a new number has not been provided. A phone number provided in the company's most recent Statement of

Revenue (submitted for Fiscal Year 2007) reaches a different telecommunications company, who indicated they were not aware of a way to reach anyone at ACCXX and believed the company to be out of business. Mail sent to the address provided to the Commission has not been returned as undeliverable.

ACCXX has not submitted a 2006 annual report or a fiscal year 2008 statement of revenue to the Commission. No complaints against the company have been filed with the Commission since the commencement of the Electronic Filing and Information System.

Because ACCXX cannot be contacted, Staff recommends that the Commission cancel the company's certificate of service authority to provide intrastate interexchange telecommunications service and its accompanying tariff.

The Commission has the authority to cancel a certificate pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Staff's motion and recommendation, the Commission finds that the certificate of service authority and accompanying tariff granted to ACCXX Communications, LLC shall be canceled.

IT IS ORDERED THAT:

- 1. The certificate of service authority to provide intrastate interexchange telecommunications service, granted to ACCXX Communications, LLC in Case Number TA-2002-461, is canceled.
- 2. ACCXX Communications, LLC's tariff, P.S.C. Mo. Tariff No. 1, is canceled.

- 3. This order shall become effective on October 7, 2007.
- 4. This case may be closed on October 8, 2007.
