APPLICATION

UKI Communications, Inc. ("Applicant" or "UKI"), a Nevada corporation, hereby respectfully requests the Missouri Public Service Commission ("Commission") to issue an order granting Applicant a Certificate of Service Authority to provide intrastate interexchange telecommunications services pursuant to Chapter 392 of the Missouri Revised Statutes. Applicant further requests classification as a competitive telecommunications company and waiver of the standard rules and statutory provisions normally waived for interexchange carriers. The following information and exhibits are furnished in support thereof:

Applicant proposes to initially provide 1+ and Travel Card services by reselling the switched service offerings of underlying facilities-based carriers to prospective customers within the State of Missouri. Applicant proposes to offer these services to all points (originating and terminating) within and throughout the entire state of Missouri. For further details on each of these services, see "Description of Services" in the initial tariff.

- 4. Applicant's tariff is being simultaneously filed with the application. The tariff, which has a 45-day effective date, contains the rules and regulations applicable to its customers, a description of the services offered and a list of rates associated with such services.
- 5. Applicant requests classification as a competitive telecommunications company within the state of Missouri. UKI believes that its proposed services will be subject to sufficient competition to justify a lesser degree of regulation. Granting of this application will allow greater price and service options for telephone users.
- 6. Pursuant to Section 386.570 (Cum. Supp. 1994), UKI will comply with all applicable Commission Rules except those which are specifically waived by the Commission pursuant to the request for competitive classification included herein. UKI requests that the Commission waive the rules and statutes normally waived for interexchange carriers.

WHEREFORE, having demonstrated its resources and ability to provide telecommunications service to the public, UKI requests that the Missouri Public Service Commission enter an order granting a Certificate of Service Authority authorizing UKI to operate as a resale common carrier of intrastate interexchange telecommunications services pursuant to Chapter 392 of the Missouri

Revised Statutes, and the applicable Commission Rules. Applicant also requests classification as a competitive telecommunications company and waiver of the rules and statutory provisions normally waived for interexchange carriers.


