**ORDER APPROVING COMPLIANCE TARIFF**

On May 18, 2017, Union Electric Company d/b/a Ameren Missouri filed a tariff to comply with the Commission’s order of April 13, in which the Commission granted Ameren Missouri’s request for a variance regarding the inspection and testing of its natural gas meters. That tariff carries a June 17 effective date.

Staff filed its recommendation regarding Ameren Missouri’s tariff on June 2. Staff indicates the tariff complies with the Commission’s order and advises the Commission to either approve the tariff, or allow it to go into effect by operation of law. The Commission will approve the tariff.
