On May 5, 2015, The Empire District Electric Company issued tariffs to establish solar rebate payment procedures, and to revise its net metering tariffs to accommodate the payment of solar rebates. Empire has amended its tariffs to comply with a recent Missouri Supreme Court decision that determined a statutory exemption from the payment of solar rebates, upon which Empire had relied to avoid paying solar rebates, was repealed by the passage of a subsequent initiative petition. Empire's tariffs carry a June 4 effective date, but Empire asks the Commission to approve the tariffs at its May 6 agenda meeting, with the tariffs to take effect ten days after the effective date of the approving order. Empire also seeks a waiver of the 60-day filing notice requirement of Commission Rule 4 CSR 240-4.020(2).

Empire explains that it has worked with the Staff of the Commission, Public Counsel, and other stakeholders to craft the language of the tariffs. It contends expedited approval of the tariffs is necessary to allow Empire's customers to begin receiving solar rebates as soon as possible. Public Counsel filed a response on May 5, voicing its support for the expedited approval of Empire's tariffs. Staff filed a recommendation in favor of the tariff. The Commission finds that the submitted tariffs should be approved on less than thirty days' notice so that Empire's customers can begin to receive solar rebates as soon as possible.

THE COMMISSION ORDERS THAT:
