ORDER CANCELING CERTIFICATE AND ACCOMPANYING TARIFF

Issue Date: July 7, 2015 Effective Date: July 17, 2015

On June 15, 2015, the Staff of the Missouri Public Service Commission filed a motion requesting Globalinx Enterprises, Inc. ("Globalinx") certificate of service authority and accompanying tariff to provide interexchange telecommunication services in the State of Missouri be cancelled.

In File Number XN-2015-0159, the Commission granted Globalinx a certificate of service authority to provide interexchange telecommunication service in the State of Missouri. The Company's tariff, P.S.C. Mo No. 1, was also approved.

Staff states in its motion that Globalinx contacted Staff via letter stating Globalinx was no longer providing service in Missouri and requested the Commission cancel Globalinx's certificate of service authority. Staff recommends that the Commission cancel the company's certificate of service authority to provide interexchange telecommunications services, and the company's accompanying tariff.

On June 16, 2015, the Commission issued an Order Establishing Time to Respond allowing any parties to file an objection or request a hearing to do so no later than June 26, 2015. No objections or requests for a hearing were filed.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate or service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Staff's motion, the Commission finds that the certificate of service authority and accompanying tariff granted to Globalinx Enterprises, Inc., shall be canceled.

THE COMMISSION ORDERS THAT:

- 1. The certificate of authority to provide interexchange telecommunications services granted to Globalinx Enterprises, Inc., in File Number XN-2015-0159, is canceled.
 - 2. Globalinx Enterprises, Inc.'s tariff, P.S.C. Mo No. 1, is canceled.
 - 3. This order shall become effective on July 17, 2015.
 - 4. This case may be closed on July 18, 2015.
