
Dear Mr. Roberts:

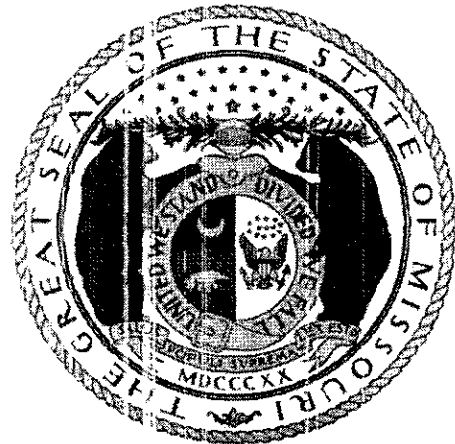

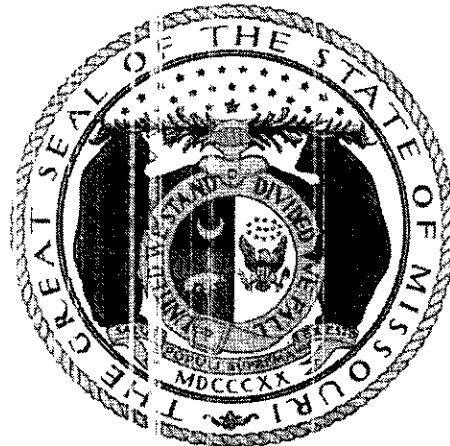
