ORDER APPROVING COMPLIANCE TARIFF SHEETS

Issue Date: June 26, 2023

Effective Date: July 13, 2023

On November 10, 2022, Evergy Missouri Metro, Inc. d/b/a Evergy Missouri Metro (EMM or “the Company”) filed an application and exemplar tariff sheets asking the Commission to approve a Special High Load Factor Market Rate (Schedule MKT). On May 24, 2023, the Commission issued its *Order Approving Stipulation and Agreement* (Order) which approved exemplar tariff wording and directed the Company to submit tariff sheets in compliance with the Order.

On June 13, 2023, EMM filed compliance tariff sheets, assigned Tracking No. YE-2023-0217. The tariff sheets carried an effective date of July 13, 2023. The Staff of the Commission (Staff) filed its recommendation of approval of the compliance tariff sheets on June 23, 2023. The Commission set a time for other responses, but no other parties responded or objected to EMM’s filed compliance tariff sheets.

Upon reviewing the tariff sheets and Staff’s recommendation, the Commission finds the proposed tariff sheets comply with the Commission’s Order and will approve them.

In order to allow these unopposed tariff sheets to go into effect on the date requested, the Commission finds it reasonable to make this order effective in less than

30 days.¹

THE COMMISSION ORDERS THAT:

1. The proposed tariff sheets filed on June 13, 2023, by EMM and assigned Tracking No. YE-2023-0217, are approved to become effective on July 13, 2023. The specific tariff sheets approved are:
