ORDER CANCELING CERTIFICATE AND ACCOMPANYING TARIFF

Issue Date: August 8, 2017

Effective Date: August 18, 2017

On July 13, 2017, the Staff of the Missouri Public Service Commission filed a motion requesting Tele Circuit Network Corporation's ("Tele Circuit") certificate of service authority and accompanying tariff to provide interexchange telecommunication service in the State of Missouri be cancelled.

In File Number XA-2004-0483, the Commission granted Tele Circuit a certificate of service authority to provide interexchange telecommunication service in the State of Missouri. The Company's tariff, P.S.C. Mo No. 1, was also approved.

Staff states in its motion that Tele Circuit notified the Commission that Tele Circuit was no longer providing service in Missouri and the company wished to surrender its certificate of service authority. Staff recommends that the Commission cancel the company's certificate of service authority to provide interexchange telecommunications services, and the company's accompanying tariff.

On July 13, 2017, the Commission issued an Order Establishing Time to Respond allowing parties until July 24, 2017, to file an objection or request a hearing. No objections or requests for a hearing were filed.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, “[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected.”

Based on Staff’s motion, the Commission finds that the certificate of service authority and accompanying tariff granted to Tele Circuit Network Corporation, shall be canceled.

THE COMMISSION ORDERS THAT:

1. The certificate of authority to provide interexchange telecommunications services granted to Tele Circuit Network Corporation, in File Number XA-2004-0483, is canceled.
2. Tele Circuit Network Corporation’s tariff, P.S.C. Mo No. 1, is canceled.
3. This order shall become effective on August 18, 2017.
4. This case may be closed on August 19, 2017.
