ORDER RECOGNIZING CORPORATE NAME CHANGE
AND APPROVING TARIFF SHEETS

Issue Date: September 12, 2007

Effective Date: November 1, 2007

Syllabus: This order recognizes Cinergy Communications Company's name change to Norlight, Inc., and approves the tariff adoption notices and revised tariff title page.

On August 23, 2007, Cinergy Communications Company (Cinergy) filed with the Missouri Public Service Commission a request to change its name to Norlight, Inc. Cinergy filed adoption notices and a revised tariff title page, effective November 1, 2007. Cinergy filed substitute tariff sheets on September 6, 2007.

On September 10, Staff filed its Recommendation. Staff stated that Cinergy has complied with the Commission rule regarding name changes. Further, Staff recommended the Commission recognize the name change and approve the accompanying adoption notices and revised tariff title page.

The Commission has reviewed the application, finds that it substantially complies with Commission Rules 4 CSR 240-2.060(5) and 4 CSR 240-3.545(20), and finds that it should recognize the name change. The Commission will also approve the adoption notices and revised tariff sheets.

IT IS ORDERED THAT:

1. The Commission recognizes Cinergy Communications Company's name change to Norlight, Inc.

2. The Commission approves the revised tariff sheets, as substituted on September 6, 2007. Those tariff sheets were assigned tariff file numbers YX-2008-0127, YC-2008-0128, and YC-2008-0149, and are approved for service on and after November 1, 2007. The tariff sheets approved are:
