ORDER APPROVING COMPLIANCE TARIFF SHEETS

Issue Date: February 17, 2022

Effective Date: February 28, 2022

On December 22, 2021, the Commission approved multiple stipulations and agreements that fully resolved Union Electric Company d/b/a Ameren Missouri's request to increase the company's annual revenues from its provision of natural gas service. On January 19, 2022, the Commission formally rejected the tariff sheets Ameren Missouri originally filed on March 31, 2021, and authorized Ameren Missouri to file tariff sheets necessary to implement the provisions of the approved stipulations and agreements. Ameren Missouri filed its compliance tariff sheets on January 28, 2022, to be effective on February 28, 2022.

The Commission issued an order on January 31, 2022, directing its Staff to file a recommendation regarding Ameren Missouri's tariff sheets by February 10, 2022. That order also directed any other party wishing to file a recommendation regarding Ameren Missouri's tariff to do so no later than February 10, 2022.

On February 10, 2022, the Commission's Staff filed its recommendation regarding Ameren Missouri's compliance tariff. Staff concludes the tariff sheets comply with the

Commission's Order Approving Stipulations and Agreements, and recommends the Commission either issue an order approving the compliance tariff sheets to be effective on February 28, or allow them to take effect by operation of law on that date. No other party filed a recommendation, and no party has filed a response to Staff's recommendation.

The Commission has reviewed the proposed tariff sheets and Staff's recommendation. The Commission concludes the submitted compliance tariff sheets are consistent with the approved stipulations and agreements and should be approved. The Commission finds it reasonable to make this order effective in less than thirty days so that the effective date of the order will match the effective date of the tariff.

THE COMMISSION ORDERS THAT:

- 1. The proposed natural gas service tariff sheets submitted under Tariff No. YG-2022-0215 by Union Electric Company d/b/a Ameren Missouri, as substituted, are approved effective on and after February 28, 2022.
 - 2. This order shall become effective on February 28, 2022.
