Consolidated Communications Enterprise Services, Inc. d/b/a Consolidated Communications hereby respectfully submits the following tariff pages with revisions effective March 1, 2020.

Section 4 - Fourth Revised Sheet No. 33
Section 11 - Fifth Revised Sheet No. 53

Section 11 - Second Revised Sheet No. 60

The purpose of this filing is to make the following tariff changes:

- Residential Basic Local Telecommunication Service rate will increase by \$2.00 (Current access line rate is \$11.95 increasing to \$13.95)
- Residential Basic Local Telecommunication Service (including MCA Calling Scope) rate will increase by \$2.00 (Current access line rate is \$25.95 increasing to \$27.95)
- Commercial Basic Local Telecommunication Service rate will increase by \$3.10 (Current access line rate is \$26.90 increasing to \$30.00)
- Commercial Basic Local Telecommunication Service (to add MCA Calling Scope to Basic Local Service) deleted as this is included in the rate listed for Commercial Basic Local Telecommunications Service (MCA Calling Scope)
- Voice Advantage and Voice Advantage II bundles will increase by \$2.00
- Voice Advantage 600 Bundle was deleted as we no longer have customers on that bundle
- ExpansionPAK II Bundles will have the components of the total bundle rate re-allocated within the bundle due to the business access line rate increase. The total bundle rate will not change and customers will not see an increase in their current bundle rate.
- ExpansionPAK II Bundle - Month-to-Month rate will increase by \$3.10 .
