On behalf of Spire Missouri Inc. (“Company” or “Spire”), I am transmitting herewith for electronic filing with the Missouri Public Service Commission (“Commission”), Revised Tariff Sheet No. 21.1, which contains a section of the Index of Certificated Areas within the Spire Missouri West service territory.
