CONNECTIONS WITH CUSTOMER-PROVIDED EQUIPMENT

A. GENERAL

- 1. Customer-provided equipment may be used with the facilities furnished by the Telephone Company, for telecommunication service, provided that such equipment will be connected, maintained and operated as specified in this tariff.
- 2. Where the use of any customer-provided equipment involves direct electrical connection to the facilities of the Telephone Company, such connection shall be made through a connecting device furnished and installed by the Telephone Company at charges specified in this tariff.
- 3. The customer is not permitted to create additional channels from facilities provided by the Telephone Company, or to resell or share services with any party through extension of customer-provided channels, or equipment, except as otherwise provided in this tariff.
- 4. If customer-provided equipment is used in violation of the provisions of this tariff the Telephone Company will take such action as it deems necessary for the protection of the network.
- 5. After notification by the Telephone Company of such violation, the customer shall discontinue such use and confirm in writing to the Telephone Company within 10 days that such violation has ceased. Failure of the customer to conform to this requirement shall result in suspension of service.

The Telephone Company shall not be responsible to the customer if changes in criteria in this tariff or changes in any of the facilities or operations or procedures of the Telephone Company render any customer-provided equipment obsolete, or required modification or alteration of such equipment, or otherwise affect its use of performance. The Telephone Company reserves the right to change the standards of its equipment as the requirements of the telephone business may direct.

- C. OBLIGATIONS OF THE CUSTOMER
 - The customer will at his expense:
 - a. Provide and install all wiring from point of connection with the Telephone Company facilities and make the actual connection with it.
 - b. Provide power to operate his equipment in conformity with Telephone Company specifications.
 - c. Maintain his equipment to assure proper operation within standards of the Telephone Company
 - d. Replace or modify his equipment if requested by the Telephone Company if it becomes obsolete or incompatible because of changes in standards or operating procedures.
 - e. Disconnect equipment upon notification that it is causing or is likely to cause interference or hazard to the network or company personnel, or to other customers of the Company.
 - f. Pay a service maintenance charge of \$25.00 for visits to his premises when the service difficulty is caused by the customer-provided equipment.
 - g. Provide the space and AC power required by the Telephone Company.
 - 2. The customer will be required to sign a contract for the connecting device as specified by the Telephone Company
 - 3. The customer will not be allowed to "hard wire" to the Telephone Company's connecting device unless the device is so designed that there is no other way to make the connection. The customer will notify the Telephone Company before any entry to the connecting device is made and Telephone Company personnel will be present to make the entry. The Telephone Company will make one (1) free trip to make an entry. Each additional trip, for the same problem, the service maintenance charge shown in C. 1. f., above will apply.
