**ORDER APPROVING TARIFF**

Issue Date: July 27, 2016

Effective Date: August 1, 2016

On June 1, 2016<sup>1</sup>, Kansas City Power & Light Company filed tariff sheets to modify its Demand Side Investment Mechanism (“DSIM”). The Commission rejected those tariff sheets on July 20 and ordered KCP&L to file a tariff that complied with the order.

On July 22, KCP&L filed a tariff in an attempt to comply with the Commission’s July 20 order. KCP&L also filed a motion for expedited treatment in which it asks the Commission to approve the tariff by August 1. On July 25, the Staff of the Commission recommended that the Commission approve the tariff. The Commission allowed parties until July 26 to object to the tariff or the Staff Recommendation. The Commission received no objections.

The Commission has authority to approve tariff sheets pursuant to Sections 393.140(11) and 393.150, RSMo. The Commission has reviewed the tariff sheet and Staff's recommendation. The Commission finds that the tariff sheet conforms to the Commission's July 20 order and should be approved. Furthermore, the Commission finds good cause for the tariff to go into effect on less than thirty days’ notice because an

August 1 effective date maintains the six-month adjustment intervals integral to the operation of the DSIM.

**THE COMMISSION ORDERS THAT:**

1. The tariff filed by Kansas City Power & Light Company on July 22, 2016, and assigned tariff number YE-2017-0017, is approved to become effective on August 1, 2016.
