On behalf of Liberty Utilities (Midstates Natural Gas) Corp. d/b/a Liberty Utilities' ("Liberty Utilities" or "Company"), transmitted herewith for electronic filing with the Missouri Public Service Commission ("Commission") are certain revised tariff sheets.

These tariff sheets are being filed to comply with the Commission's Report and Order issued in Case No. GR-2014-0152 on December 3, 2014, effective January 2, 2015. These compliance tariff sheets are designed to produce an increase in annual revenue of \$4,867,076, excluding gross receipts and sales taxes.
