Enclosed for filing on behalf of Missouri-American Water Company please find the following revised water tariff sheets:

- PSC MO NO 13 – 5th Revised Table of Contents, Sheet 1
- PSC MO NO 13 – 3rd Revised Sheet RT 3.1
- PSC MO NO 13 – 3rd Revised Sheet RT 4.1
- PSC MO NO 13 – 3rd Revised Sheet 5.1
- PSC MO NO 13 – 1st Revised Sheet 5.3
- PSC MO NO 13 – 1st Revised Sheet 5.5

The purpose of these tariff sheets are as follows:

- Table of Contents, Sheet 1, simply corrects the Table of Contents page for the rate section of the Company's water tariff.
- Sheets RT 3.1 and RT 4.1 simply add the option for annual billing of the Private Fire Service charge, which the Company currently employs in its St. Louis Metro District.
- Sheets 5.1, 5.3 and 5.5 eliminate the restriction on availability of Rate J to allow apartment dwellings, hotels, hospitals, and educational institutions who otherwise qualify for Rate J to subscribe to this service. (This maintains the status quo in the St. Louis Metro District.)

Please note the tariff sheets bear an issue date of today and are proposed to become effective on October 21, 2016. If there are any questions regarding the filing, please direct them to me.
