**ORDER RECOGNIZING NAME CHANGE  
AND APPROVING TARIFF SHEETS**

Issue Date: July 23, 2012

Effective Date: August 1, 2012

On July 2, 2012, Liberty Energy (Midstates) Corp. (“Liberty”) filed the above-referenced name change. Liberty did so pursuant to a Commission Order Approving Unanimous Stipulation and Agreement in File No. GM-2012-0037. Liberty’s name change request was accompanied by tariff sheets bearing an effective date of August 1, 2012.

On July 23, 2012, Staff filed its Recommendation. Staff stated that the applicant has complied with the Commission rule regarding name changes. Further, Staff recommended the Commission recognize the name change and approve the tariff sheets.

The Commission has reviewed the application, finds that it substantially complies with Commission Rule 4 CSR 240-2.062, and finds that it should recognize the name change. The Commission will also approve the revised tariff.

**THE COMMISSION ORDERS THAT:**

1. The Commission recognizes the name change of Liberty Energy (Midstates) Corp. to Liberty Energy (Midstates) Corp., d/b/a Liberty Utilities.

2. The Commission approves the tariff sheets Liberty Energy (Midstates) Corp., d/b/a Liberty Utilities filed on July 22, 2012, reflecting its new name. Those tariff sheets were assigned tariff file number YG-2013-0003, and are approved for service on and after August 1, 2012. The tariff sheets approved are:
