ORDER RECOGNIZING NAME CHANGE AND APPROVING TARIFF SHEETS

On July 25,¹ the Commission received the above-referenced requests for name change. They were filed pursuant to Commission Rule 4 CSR 240-2.060(5). Accompanying the requests were the above-referenced tariffs, which bear an effective date of August 24.

On August 3, Staff filed its Recommendation. Staff stated that the applicant has complied with the Commission rule regarding name changes. Further, Staff recommended the Commission recognize the name change and approve the tariff sheets.

The Commission has reviewed the applications, finds that they substantially comply with Commission Rules 4 CSR 240-2.060(5) and 4 CSR 240-3.645, and finds that it should recognize the name change. The Commission will also approve the revised tariffs.
