ORDER APPROVING TARIFF IN COMPLIANCE WITH COMMISSION ORDER ON INFRASTRUCTURE SYSTEM REPLACEMENT SURCHARGE PETITION

Issue Date: April 27, 2022 Effective Date: May 7, 2022

On December 23, 2021, Spire Missouri, Inc. d/b/a Spire filed a tariff sheet and application requesting the Commission authorize Spire to change its infrastructure system replacement surcharge (ISRS). On April 21, 2022, the Commission issued its *Order Approving Unanimous Stipulation and Agreement* (Order). The Order rejected the original tariff sheet, and further authorized Spire to submit a tariff complying with the Order.

On April 21, 2022, Spire filed a compliance tariff sheet, assigned Tariff No. YG-2022-0250, with an effective date of May 21, 2022. On the same date, Spire filed a *Motion for Expedited Treatment*, requesting the proposed tariff sheet go into effect on May 1, 2022. On April 25, 2022, Staff recommended the Commission approve the compliance tariff. No objections to the tariff sheet or the request for expedited treatment were received from any party.

Based on Staff's recommendation, the Commission finds the tariff sheet complies with the Commission's Order. Thus, the Commission will approve it.

Spire requested the tariff sheet be approved to take effect on May 1, 2022. The Commission must give parties time to seek rehearing of any Commission order. However, the Commission will approve the tariff sheet to take effect in fewer than 30 days from the date of issuance.

THE COMMISSION ORDERS THAT:

1. The following tariff sheet, assigned Tariff No. YG-2022-0250 and filed by Spire on April 21, 2022, is approved and shall be effective on May 7, 2022:
