The revised tariff sheets are designed to revise the service area map and legal description for Mid-MO’s service area as ordered by the Commission in its September 29, 2021 *Order Granting Certificate of Convenience and Necessity* (“Order”). The *Order* provides in paragraph 2: “Mid-MO is granted a CCN authorizing it to operate, maintain, control, and manage the portion of its sewer system outside of its currently existing service area to include the land application area set out in Attachments A and B of Staff’s Memorandum attached to Staff’s Recommendation.”

The 1st Revised Sheet No. 3 reflects the revised service area map provided in Attachment A of Staff’s *Memorandum*, and the 1st Revised Sheet Nos. 4 and 5 reflect the revised legal description provided in Attachment B of Staff’s *Memorandum*. Each revised tariff sheet bears an issue date of October 7, 2021, and a proposed effective date of November 6, 2021 (30 days).
