**ORDER APPROVING TARIFF SHEET**

Issue Date: June 1, 2023

Effective Date: June 12, 2023

On January 17, 2023, Evergy Missouri West, Inc. d/b/a Evergy Missouri West filed a tariff sheet, assigned Tracking No. JE-2023-0131, designed to revise Evergy Missouri West's rates for cogeneration and net metering as required by Commission Rules 20 CSR 4240-3.155, 20 CSR 4240-20.060, and 20 CSR 4240-20.065. The tariff sheet had an original effective date of February 16, 2023. The Commission suspended the tariff sheet until June 12, 2023.

On May 31, 2023, the Staff of the Commission (Staff) filed a recommendation. Staff recommended the Commission approve the tariff sheet to become effective on June 12, 2023, with a correction to the sheet number.<sup>1</sup> Staff also recommended that the

Commission order Evergy Missouri West to file a public version of the data required by 20 CSR 4240-3.155(4).

The Commission has reviewed the tariff sheet and Staff's recommendation and determines that the tariff sheets should be approved. Additionally, the Commission will direct Evergy Missouri West to file a public version of the data required by 20 CSR 4240-3.155(4). The Commission will approve the tariff sheet to become effective on June 12, 2023. So that the tariff sheet may become effective as requested, the Commission finds it reasonable for this order to become effective in less than 30 days.

**THE COMMISSION ORDERS THAT:**

1. The tariff sheet submitted by Evergy Missouri West on January 17, 2023, Tracking No. JE-2023-0132, is approved to become effective on June 12, 2023. Evergy Missouri West shall submit a tariff sheet with the correct numbering as noted above. The tariff sheet approved is:

**4th Revised Sheet No. 102.1, Canceling 3rd Revised Sheet No. 102.1**

2. Evergy Missouri West shall file a public version of the data required by 20 CSR 4240-3.155(4) no later than June 12, 2023.
3. This order shall be effective on June 12, 2023.
4. This file shall close on June 13, 2023.
