**ORDER CANCELING CERTIFICATE**  
**AND ACCOMPANYING TARIFF**

Effective Date: April 28, 2006

On April 13, 2006, the Staff of the Commission filed a motion asking the Commission to cancel the certificate of service authority and accompanying tariff of Affordaphone, Inc., a company that has been authorized to offer basic local telecommunications services by the Commission.

In Case Number CA-2002-1158, the Commission granted Affordaphone a certificate to provide basic local telecommunications services. A preexisting tariff by Affordaphone was adopted and approved and became Affordaphone's tariff, MO PSC No. 1.

Staff's motion states that Affordaphone indicated in its 2005 Annual Report and its confidential Statement of Revenue that it is no longer in business. Furthermore, Affordaphone reported \$0 revenue and no access lines. Affordaphone also failed to file its annual registration report according to the Missouri Secretary of State's office, and its authority to do business in the state

of Missouri was revoked January 5, 2006. Staff recommends that the Commission cancel the company's certificate of service authority and accompanying tariff, MO PSC No. 1, to provide basic local telecommunications services.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate or service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Staff's motion and Affordaphone's request to cancel the certificate and tariff included in its 2005 Annual Report, the Commission finds that the certificate of service authority and accompanying tariff granted to Affordaphone, Inc., shall be canceled.

**IT IS ORDERED THAT:**

1. The certificate of authority to provide basic local telecommunications services granted to Affordaphone, Inc., in Case Number CA-2002-1158 is canceled.
2. Affordaphone, Inc.'s tariff, MO PSC No. 1, is canceled.
3. This order shall become effective on April 28, 2006.

4. This case may be closed on April 29, 2006.
