ORDER APPROVING TARIFF SHEETS

On January 12, 2015, KCP&L Greater Missouri Operations Company filed an application to discontinue its Multi-Family Rebate Program and Energy Star New Homes demand-side management programs because the programs are not cost effective due to a low level of participation. With its application, the company filed proposed tariff sheets with an effective date of February 11, 2015. Those tariff sheets reflect the company's request.

The Commission issued notice of the application and directed that requests for a hearing be filed no later than January 28, 2015. There were no requests for a hearing.

On January 26, the company filed substitute tariff sheets to freeze, rather than discontinue, two programs in order to allow several pending projects to be completed but to prevent future applications from being approved under the programs.

Through Commission rule 4 CSR 240-20.094(5) the company is permitted to file this application and must file documents required by 4 CSR 240-3.164(5). On January 30, 2015, the Staff of the Commission filed its recommendation and informed the Commission that the company's application complies with the Commission's rules. Staff recommends that the Commission approve the application and direct the company to notify Staff when those pending projects are completed.

Based on the company's application and Staff's recommendation and verified memorandum, the Commission will approve the proposed tariff sheets and direct the company to notify Staff when those pending projects are completed.
