ORDER APPROVING TARIFF

Issue Date: October 29, 2014

Effective Date: November 1, 2014

On October 16, Union Electric Company d/b/a Ameren Missouri ("Ameren"), filed a tariff proposed to become effective November 1, 2014. The tariff reflects a change in Ameren's Purchased Gas Adjustment (PGA) factor as a result of estimated changes in the cost of natural gas for the 2014-2015 winter season. Ameren's filing will decrease the firm PGA factor for the winter season for Ameren's Rolla system to \$0.3688 per hundred cubic feet ("Ccf"), from the current firm PGA factor of \$0.4445 per Ccf for the first 30 Ccfs and, for all other Ccfs, decrease to \$1.1640 from \$1.2397. This represents a decrease of \$0.757 per Ccf for the first 30 Ccfs and \$0.9243 per Ccf for all other Ccfs.

Ameren's filing will decrease the firm PGA factor for the winter season for Ameren's non-Rolla system to \$0.1878 per hundred Ccf, from the current firm PGA factor of \$0.2378 per Ccf for the first 30 Ccfs and, for all other Ccfs, decrease to \$0.9830 from \$1.1640. This represents a decrease of \$0.05 per Ccf for the first 30 Ccfs and \$0.181 per Ccf for all other Ccfs.

The Commission's Staff filed its recommendation on October 24, 2014. Staff recommends the rates be approved on an interim basis, subject to refund pending final

Commission decision in this file and File No. GR-2014-0061. Staff also asks to be allowed until December 18, 2015, to submit its results and recommendations regarding the information included in Ameren's ACA filing.

The Commission has reviewed the proposed tariff and Staff's recommendation. The Commission finds that the proposed tariff conforms to Ameren's Commissionapproved PGA Clause. In addition, because Ameren's PGA clause allows for PGA change filings to take effect on ten days' notice, good cause has been shown pursuant to Section 393.140(11), RSMo 2000, to permit the tariff to become effective on less than 30 days' notice. The Commission concludes that the proposed tariff should be approved to become effective on November 1, 2014, on an interim basis, subject to refund, pending final Commission decision in this file and File No. GR-2014-0061.

THE COMMISSION ORDERS THAT:

1. The proposed tariff filed on October 16, 2014, by Union Electric Company d/b/a Ameren Missouri, assigned Tracking Number JG-2015-0163 and bearing an effective date of November 1, 2014, is approved on an interim basis, subject to refund, pending final Commission decision in this file and File No. GR-2014-0061. The tariff sheets approved is:
