On January 13, 2023, The Empire District Gas Company d/b/a Liberty ("EDG") submitted PSC MO No 2, Revised Sheet No. R51b, to correct an error in the compliance tariff sheets filed pursuant to the Commission's Report and Order issued June 23, 2022, effective July 3, 2022, in EDG's last general rate case. Since the submission on January 13, an additional error regarding the low-income affordability program ("LIAP") compliance tariff sheets was discovered.

To correct that error, a substitute tariff sheet submission is being made at this time. As a substitute, the revised tariff sheet continues to bear an issue date of January 13, 2023, and an effective date thirty days thereafter (February 12, 2023).
