#### MOTION TO CANCEL CERTIFICATE OF SERVICE AUTHORITY

COMES NOW the Staff of the Missouri Public Service Commission (Staff), by and through the undersigned attorney, and moves for the Missouri Public Service Commission (Commission) to cancel the certificate of service authority of Network US, Inc. d/b/a CA Affinity (CA Affinity or Company) and states as follows:

- 1. On November 29, 2001, the Commission granted CA Affinity a certificate of service authority to provide competitive intrastate interexchange telecommunications services in Missouri in Case No. TA-2002-188.
- 2. On October 17, 2009, CA Affinity's fictitious name registration expired due to the Company's failure to renew its registration with the Missouri Secretary of State (SOS). See Attachment A.
- 3. According to §417.200, "...it shall be unlawful for any person to engage in or transact any business in this state under a fictitious name without first registering same with the secretary of state as herein required."
- 4. On August 25, 2010, the SOS administratively dissolved the parent company, Network US, Inc., for failure to file a correct and current annual report. According to §351.476.1, a corporation administratively dissolved may not carry on any business except that necessary to wind up and liquidate its business and affairs. See Attachment B.

- 5. Because the Company can no longer lawfully provide telecommunications services in Missouri, the Staff recommends that the Commission cancel the certificate.
- 6. The Commission has the authority to cancel a telecommunications certificate pursuant to §392.410.5 RSMo 2000, which provides "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."
- 7. The Commission need not hold a hearing if, after proper notice and opportunity to intervene, no party requests such a hearing. *State ex rel. Rex Deffenderfer Enterprises, Inc. v. Public Service Commission*, 776 S.W. 2d 494 (Mo. App. W.D. 1989).

WHEREFORE, the Staff respectfully recommends that the Commission cancel the tariff and certificate of service authority of Network US, Inc. d/b/a CA Affinity to provide competitive intrastate interexchange telecommunications services in Missouri.
