#### ORDER SUSPENDING TARIFF SHEET

The Commission is granting KCP&L Greater Missouri Operations Company's ("GMO") "request for merger of tariff filing" ("motion"). In the motion, GMO states that it inadvertently omitted one tariff sheet from the filing that initiated this general rate case and states that it has filed that tariff sheet with a proposed effective date of August 6, 2016. GMO asks that the Commission suspend the tariff sheet consistently with the other tariff sheets<sup>2</sup> and consider it with the others filed in this case.

The Commission may suspend a tariff for 120 days beyond the tariff's effective date pending a full hearing on the propriety of the tariff<sup>3</sup> and, if that time is not enough to conclude a full hearing on the tariffs' propriety, the Commission may extend the suspension for not more than six months.<sup>4</sup> GMO states that the motion is the result of discussions with Staff.

The Commission will grant the motion.
