**ORDER APPROVING DEMAND SIDE INVESTMENT MECHANISM
RIDER RATE ADJUSTMENT TARIFF**

Issue Date: July 14, 2021

Effective Date: August 1, 2021

On June 1, 2021, Evergy Metro, Inc. d/b/a Evergy Missouri Metro filed a tariff sheet, with supporting testimony, to adjust charges related to its approved Demand Side Investment Mechanism (DSIM) Rider under the Missouri Energy Efficiency Investment Act (MEEIA). The tariff sheet filing was assigned Tariff No. JE-2021-0213. On June 28, 2021, Evergy Missouri Metro filed a substitute tariff sheet (Substitute Tariff Sheet) to address certain calculation issues related to a Unanimous Partial Stipulation and Agreement approved in File No. EO-2020-0227.¹ The Substitute Tariff Sheet carries an effective date of August 1, 2021.

The Commission issued notice of the filing, set an intervention deadline, and directed the Staff of the Missouri Public Service Commission (Staff) to submit a recommendation. On July 1, 2021, Staff recommended the Commission approve Evergy Missouri Metro's Substitute Tariff Sheet. Commission rules allow responses to be filed

within ten days.² No responses or objections were received to either Evergy Missouri Metro's filing or Staff's recommendation.

Commission Rules 20 CSR 4240-20.093(4) and 20 CSR 4240-3.162(8) require Evergy Missouri Metro to make semi-annual adjustments of its DSIM rates to reflect the amount of revenue that has been over- or under-collected. The proposed Substitute Tariff Sheet decreases the current residential DSIM Rider rate from \$0.00600 per kWh to \$0.00589 per kWh for residential customers. For a residential customer using 1,000 kWhs, this change will decrease the customer's bill by \$0.11 per month.

The proposed Substitute Tariff Sheet would change the current non-residential DSIM Rider rate as follows:

Small General Service from \$0.00457 per kWh to \$0.00228;

Medium General Service from \$0.00535 per kWh to \$0.00498;

Large General Service from \$0.00382 per kWh to \$0.00364; and

Large Power Service from \$0.00282 per kWh to \$0.00260.

For a non-residential customer using 1,000 kWh, this would mean a \$2.29 decrease for Small General Service, a \$0.37 decrease for Medium General Service, a \$0.18 decrease for Large General Service, and a \$0.22 decrease for Large Power Service per month.

Commission Rule 20 CSR 4240-20.093(4), regarding adjustment of DSIM rates between general rate proceedings, states that if the proposed adjustments are in accordance with the rule, Section 393.1075, RSMo (2016), and the previously-approved DSIM the Commission shall issue an order approving the tariff within sixty days after the tariff is filed. The Commission has reviewed Evergy Missouri Metro's Substitute Tariff

Sheet, Staff's recommendation and accompanying memorandum, and finds that the proposed Substitute Tariff Sheet implementing the DSIM rate adjustment is in compliance with Every Missouri Metro's existing DSIM tariff and with all applicable statutes and regulations.

So that the Substitute Tariff Sheet will be effective at the time requested, this order will be effective in less than thirty days.

THE COMMISSION ORDERS THAT:

1. Every Missouri Metro's Substitute Tariff Sheet, assigned Tariff Tracking No. JE-2021-0213, is approved to be effective August 1, 2021. The tariff sheet approved is:

2. This order shall become effective on August 1, 2021.
