ORDER APPROVING COMPLIANCE TARIFFS

Issue Date: May 24, 2011

Effective Date: May 25, 2011

The Commission is approving the above-numbered compliance tariffs with expedited effective dates.

By order dated April 6, 2011, (“order”) incorporated the terms of the parties’ settlement agreement, which included the filing of tariffs. On May 18, 19, and 24, 2011, Missouri-American Water Company filed tariff sheets and substitute tariff sheets proposing an expedited effective date. On May 24, 2011, Staff filed its recommendation in favor of the tariffs without opposition to the expedited effective date of May 25, 2011. The Office of Public Counsel has taken no position and no other party has entered an appearance. Therefore, no law requires a hearing,¹ this action is not a contested case² and the Commission need not separately state its findings of fact.

Based on the pleadings, the Commission independently concludes that the tariff supports safe and adequate service at just and reasonable rates, and that good cause

supports an expedited effective date, so the Commission will grant the motion and approve the tariffs.
