## NOTICE OF PROPOSED ASSET TRANSFER

On August 15, 2006, Central Jefferson County Utilities, Inc. (Central Jefferson) filed an application with the Missouri Public Service Commission (Commission), seeking the Commission's authorization to transfer and assign certain assets of its water and sewer operations to the Jefferson County Public Sewer District (Sewer District). The proposed "Tri-Party Purchase and Sale Agreement" involves the transfer of the assets to the Sewer District, and the Sewer District entering into a long-term operation, maintenance and capital improvements agreement with Environmental Management Corporation (EMC).

Central Jefferson provides water service and sewer service to approximately 670 customers in Raintree Plantation Subdivision in Jefferson County.

The Sewer District is a public sewer district formed by the Jefferson County Commission in June of 2000, pursuant to Sections 249.430 to 249.668, RSMo.

Applications to intervene and participate in this case (Case No. SO-2007-0071) must be filed on or before September 6, 2006, with the Secretary of the Missouri Public Service Commission, Post Office Box 360, Jefferson City, Missouri 65102.
