### ORDER CANCELING CERTIFICATE AND TARIFF

On March 21, 2018, the Commission issued an order approving the application of Highway H Utilities, Inc. ("Highway H") seeking authorization from the Commission to sell water and wastewater system assets to the City of Waynesville, Missouri and Pulaski County Sewer District Number 1. As part of its order, the Commission directed Highway H to file a notice indicating when the closing on the transfer of assets was complete. Highway H filed notice on April 30, 2018, indicating that the transfer was completed on April 27, 2018. Because of the transfer, Highway H is no longer providing water or sewer service in its certificated service territory. As provided in the order issued on March 21, 2018, the Commission will now cancel Highway H's certificate of convenience and necessity to provide sewer service and its associated tariff.

#### THE COMMISSION ORDERS THAT:

 Highway H Utilities, Inc.'s Certificate of Convenience and Necessity to provide water and sewer service is canceled.

- 2. Highway H Utilities, Inc.'s water service tariff, P.S.C. MO No. 1, Original Sheets No. 1-32, Tariff Tracking No. JW-2002-0018, is canceled.
- 3. Highway H Utilities, Inc.'s sewer service tariff, P.S.C. MO No. 1, Original Sheets No. 1-31, Tariff Tracking No. JS-2002-0019, is canceled.
  - 4. This order shall be effective when issued.
