## ORDER APPROVING TARIFF SHEETS IN COMPLIANCE WITH COMMISSION ORDER

Issue Date: December 10, 2021 Effective Date: January 6, 2022

On December 1, 2021, the Commission issued its Report and Order approving a territorial agreement between Union Electric Company, d/b/a Ameren Missouri and the Board of Municipal Utilities of the City of Sikeston, Missouri. The Commission directed Ameren Missouri file compliance tariff sheets describing the modification of its service territory no later than December 11, 2021. Ameren Missouri filed revised tariff sheets on December 7, 2021, to update the service area and legal description. On December 10, 2021, the Staff of the Commission filed a recommendation that the revised tariff sheets comply with the Commission order, and the Commission should approve them.

After reviewing the revised tariff sheets and Staff's recommendation, the Commission finds that Ameren Missouri's sheets comply with the Commission's order and will approve them.
