**ORDER RECOGNIZING ADOPTION OF TARIFFS IN COMPLIANCE**  
**WITH COMMISSION ORDER**

Issue Date: August 26, 2005

Effective Date: September 22, 2005

On August 4, 2005, the Missouri Public Service Commission issued an order approving the sale of assets of Silverleaf Resorts, Inc., to Algonquin Water Resources of Missouri, LLC. To facilitate the adoption of Silverleaf's tariffs, the Commission ordered Algonquin to submit a tariff title page, a tariff adoption page and an index page for each of Silverleaf's tariffs. Algonquin did so on August 23, 2005. The effective date of the tariffs is September 22, 2005. On August 25, 2005, the Staff of the Commission filed a recommendation in this matter. Staff states that it has reviewed the tariff sheets submitted by Algonquin and that they are in compliance with the Commission's order.

The Commission has reviewed Staff's recommendation and will recognize Algonquin's adoption of Silverleaf's tariffs.

**IT IS THEREFORE ORDERED:**

1. That the adoption by Algonquin Water Resources of Silverleaf Resort, Inc.'s tariffs shall be recognized.

2. That the adopted tariff pages, Tariff File Nos. YS-2006-0126 and YW-2006-0127, are approved to become effective on September 22, 2005.
