ORDER APPROVING INTEREXCHANGE CERTIFICATE OF SERVICE AUTHORITY AND ORDER APPROVING TARIFF

Issue Date: November 8, 2005 Effective Date: November 20, 2005

This order grants Asia Talk Telecom, Inc., d/b/a HelloCom Inc., a certificate of service authority to provide interexchange telecommunications services and approves the company's proposed tariff.

Asia Talk Telecom, Inc., d/b/a HelloCom Inc., applied to the Missouri Public Service Commission on October 6, 2005, for a certificate of service authority to provide intrastate interexchange telecommunications services in Missouri under Section 392.440, RSMo 2000.¹ Asia Talk asked the Commission to classify it as a competitive company and waive certain statutes and rules as authorized by Sections 392.361 and 392.420. Asia Talk is a California corporation with its principal office located at 901 Corporate Center Drive, Suite 518, Monterey Park, California 91754.

The Commission issued a Notice of Applications for Intrastate Certificates of Service Authority and Opportunity to Intervene on October 11, 2005, directing parties

wishing to intervene to file their requests by October 26, 2005. No requests for intervention were filed.

Asia Talk filed a proposed tariff in conjunction with its application with an effective date of November 20, 2005. Asia Talk's tariff describes the rates, rules, and regulations it intends to use, identifies Asia Talk as a competitive company, and lists the waivers requested. Asia Talk intends to provide interexchange telecommunications services including direct outbound dialing (1+ and 101XXXX), 800 and 888 (inbound toll-free), travel cards, and prepaid calling cards.

In its Memorandum filed on November 2, 2005, the Staff of the Commission recommended that the Commission grant Asia Talk a certificate of service authority, competitive status, and waiver of the statutes and rules listed in the Notice. Staff recommended that the Commission approve the proposed tariff to become effective on November 20, 2005.

The Commission finds that competition in the intrastate interexchange telecommunications market is in the public interest and Asia Talk shall be granted a certificate of service authority. The Commission finds that the services Asia Talk proposes to offer are competitive and Asia Talk shall be classified as a competitive company. The Commission finds that waiving the statutes and Commission rules set out in the ordered paragraph below is reasonable and not detrimental to the public interest.

The Commission finds that Asia Talk's proposed tariff details the services, equipment, and pricing it proposes to offer, and is similar to tariffs approved for other Missouri certificated interexchange carriers. The Commission finds that the proposed tariff filed on October 6, 2005, shall be approved to become effective on November 20, 2005.

The Commission reminds the company that failure to comply with its regulatory obligations may result in the assessment of penalties against it. These regulatory obligations include, but are not limited to, the following:

- A) The obligation to file an annual report, as established by Section 392.210, RSMo 2000. Failure to comply with this obligation will make the utility liable to a penalty of \$100 per day for each day that the violation continues. 4 CSR 240-3.540 requires telecommunications utilities to file their annual report on or before April 15 of each year.
- B) The obligation to pay an annual assessment fee established by the Commission, as required by Section 386.370, RSMo 2000.
- C) The obligation to comply with all relevant laws and regulations, as well as orders issued by the Commission. If the company fails to comply, it is subject to penalties for noncompliance ranging from \$100 to \$2,000 per day of noncompliance, pursuant to Section 386.570, RSMo 2000.
- D) The obligation to keep the Commission informed of its current address and telephone number.

Furthermore, the company is reminded that, if it is a corporation, non-attorneys may not represent the company before the Commission. Instead, the corporation must be represented by an attorney licensed to practice law in Missouri.

In addition, the company is reminded that Section 392.410.5, RSMo Supp. 2004, renders the company's certificate of service authority null and void one year from the date of this order unless it has exercised its authority under that certificate.

IT IS THEREFORE ORDERED:

- 1. That Asia Talk Telecom, Inc., d/b/a HelloCom Inc., is granted a certificate of service authority to provide intrastate interexchange telecommunications services in the state of Missouri, subject to all applicable statutes and Commission rules except as specified in this order.
- 2. That the certification granted herein is conditioned upon the company's compliance with the regulatory obligations in this order.
- 3. That Asia Talk Telecom, Inc., d/b/a HelloCom Inc., is classified as a competitive telecommunications company. Application of the following statutes and regulatory rules shall be waived:

4. That the tariff filed by Asia Talk Telecom, Inc., d/b/a HelloCom Inc., on October 6, 2005, under tariff number YX-2006-0262, is approved to become effective on November 20, 2005. The tariff approved is:
