## ORDER ADOPTING A PROCEDURAL SCHEDULE AND FURTHER SUSPENDING TARIFFS

Issue Date: August 8, 2006

Effective Date: August 18, 2006

**Syllabus**: This order adopts the procedural schedule jointly proposed by the parties to this case and further suspends McLeodUSA Telecommunications Services, Inc.'s tariff filings for an additional 90 days.

On July 17, 2006, the Commission ordered the parties to this case to jointly submit a proposed procedural schedule. On July 26, 2006, the Staff of the Commission filed a proposed procedural schedule in response to that order. Since all the parties have agreed to the proposed schedule, the Commission will adopt it.

The Commission finds that the following conditions should be applied:

(A) The Commission will require that testimony be prefiled as defined in Commission Rule 4 CSR 240-2.130. All parties must comply with this rule, including the requirement that testimony be filed on line-numbered pages.

(B) Pursuant to Commission Rule 4 CSR 240-2.130(15), testimony and schedules for which a claim of confidentiality is made shall be filed in accordance with the

protective order issued in this case. Any testimony or schedule not so filed will be considered public information.

(C) The parties shall agree upon and Staff shall file a list of the issues to be heard, the witnesses to appear on each day of the hearing, the order in which they will be called, and the order of cross-examination for each witness. Any issue not contained in this list of issues will be viewed as uncontested and not requiring resolution by the Commission.

(D) Each party shall file a prehearing brief, and in addition shall file a simple and concise statement summarizing its position on each disputed issue.

(E) All pleadings, briefs, and amendments shall be filed in accordance with Commission Rule 4 CSR 240-2.080. Briefs shall follow the same list of issues as filed in the case and must set forth and cite the proper portions of the record concerning the remaining unresolved issues that are to be decided by the Commission.

(F) All parties are required to bring an adequate number of copies of exhibits that they intend to offer into evidence at the hearing. If an exhibit has not been prefiled, the party offering it should bring, in addition to the copy for the court reporter, copies for the five Commissioners, the Presiding Judge, and all counsel.

Absent Commission action, the tariff filings that are the subject of this case will go into effect on October 1, 2006. Since the proposed procedural schedule extends well beyond that date, the tariff filings will need to be suspended further.

## **IT IS ORDERED THAT:**

1. The tariffs filed on April 17, 2006, by McLeodUSA Telecommunications Services, Inc., and assigned Tariff Nos. JC-2006-0788 and JC-2006-0789, are suspended

for an additional period of 90 days beyond October 1, 2006, to December 30, 2006, or until otherwise ordered by this Commission. The tariffs suspended are:
