This revised Sheet No. 81 contains the only revision between the November 18 version and today's version. This revision more specifically defines terminology that may have been too ambiguous. Specifically, the term "regulatory rate review" is revised to read "general rate proceeding," a term defined by 4 CSR 240-3.161 and consistent with the intent behind the previous "regulatory rate review" language. Please note that this is a substantive and clarifying, amendment to the language previously submitted. Ameren Missouri has retained the tariff sheet issue date of November 18, 2016, with an effective date on and after December 18, 2016.

The purpose of this filing is to extend the Company's natural gas energy efficiency programs through December 31, 2019 or through the date Ameren Missouri's next general rate proceeding for natural gas service, whichever occurs first. The changes to the program term, measures offered and process for changing incentive amounts have been discussed with the energy efficiency stakeholder group, including Staff, and Staff's suggestions have been incorporated. No party objected to the proposed revisions prior to filing.
